1. As applicants are accepted, spaces/areas will be assigned. No **Tobacco** products will be allowed for sale or giveaway. No alcoholic beverages without special advance written permission.
2. Grayson County requires a temporary food permit, if not already permitted for Grayson County. Please see attached form. Application must be turned in **NO LATER THAN 5 DAYS BEFORE** the event. A copy of the permit and insurance needs to be provided to the Chamber office before the day of the event. All vendors will be subject to inspection by Van Alstyne Fire Department and the Grayson County Health Department. Please look up the "Texas Cottage Food Law" or HB 970 known as the Texas Baker's Bill 2013 which went into effect September 1st, 2013. **Know your rights and the laws for food handling as a vendor and what you can sell.**
3. The Chamber does its best to not have repeat menu items; however, we cannot guarantee this will not happen.
4. All applicants must include an e-mail address with the application so that as we assign your venue a location, we can let you know. Please make checks payable to **Van Alstyne Chamber of Commerce** with "Fall der All Festival Food Vendor" in the memo line. No sub-letting of the spaces will be allowed.
5. Cost of Food Vendor Space:
 - **Food Vendor Booth: \$125** per non-Chamber members and **\$100** per Chamber members.
 - **Professional Food Truck: \$175** per non-Chamber members and **\$150** per Chamber members.
 - **If you require an open flame, there will be an additional \$50 charge to cover city fees.**Please do not crowd your neighbor. Please indicate space needed so that we can properly layout the area on our maps.
6. Applicants are responsible for their tents, vehicles, props, tables, chairs, water if needed and personal trash bags and flooring if needed for setting up. Electricity will **not** be provided. It is each applicant's responsibility to bring what they require. Generators are permitted; however, quiet generators are preferred. We will not be responsible for the loss of items at any time during or after the event. Please make sure your area is clean before leaving.
7. Vehicles must be unloaded on arrival and parked in a free designated area as soon as possible. No vehicles will be allowed in the main event area after 8:45 am, October 12, 2019. **Booth setup time is from 7:00 am - 8:30 am.**
8. In keeping with the VA "Fall der All Festival" concept, merchandise/activities must be appropriate to the venue. Without previous consent, livestock and domestic animals, etc. are not allowed in the area except licensed service animals or participants in the "Scarecrow Parade."
9. All activities must remain set up until at least 5:00 pm on Saturday, October 12, 2019. All vendor items must be removed and cleaned up by 7:00 pm Saturday, October 12, 2019.
10. Texas Law requires that each vendor have a Texas resale number on file with the state of Texas. You must have a copy of your resale permit with you on the day of the event, and it must match the person who signed this contract. Note: If you are a Vendor selling homemade items, be prepared to provide evidence that sales tax was paid if required on ingredients (**you are responsible for knowing the law for sales tax on your products**). No refunds will be given if your booth is not in compliance with Texas State Law.
11. Festival Date: October 12, 2019. Rain or Shine. **NO REFUNDS.**
